Highlights of March 11, 2025 Board of Aldermen Regular Meeting

- HC Tourism Development Authority Executive Director Corrina Ruffieux reviewed a PowerPoint presentation detailing a ten-year plan for Haywood County tourism.
- Ordinance 1099, 1100 and the Consistency and Reasonableness Statement was adopted, annexing and zoning 565 Lewis Lane into the Corporate Limits of Maggie Valley. Click HERE to view 1099. Click HERE to view 1100. Click HERE to view Consistency and Reasonableness Statement.
- Budget Amendment Ordinance 1105 was adopted for Soco Road Pedestrian Project and Bethel Village Road Project \$409,996.31. To view Click HERE.
- The Audit Contract with Martin Starnes & Associates, CPAs, PA. \$30,620 was approved. Click <u>HERE</u>.
- The Papertown Market event was approved for April 19, 2025.
- Budget Amendment Ordinance 1106 was adopted for restroom floors for R & R, Parham Park, and the Pavilion. To view click HERE.
- Board members voted to help the Chamber with Windows for MV's old Civic Building in the amount of \$2,800.
- Budget Amendment Ordinance 1107 was adopted for the purchase of a 2025 Maverick for Administration and two new police vehicles: \$121,900.00. To view click HERE.

- The Board approved the Cashflow Bridge Loan at 0% interest: \$23,440.11.
- The purchase of a salt bin building was approved with funds remaining in the Public Works budget: \$11,584.00
- The Board voted to accept the Quotation from Custom Paving in the amount of \$17,615 for the Parham Memorial Park project.
