# **North Carolina Helene Recovery**

## **Key Messages**

- FEMA funding is available to support repairs on private roads and bridges, even if your primary home is not damaged. For more information or to schedule an inspection, call 800-621-FEMA (3362).
- Qualifying private nonprofit houses of worship may be eligible for FEMA grants to cover Helene expenses. FEMA's Public Assistance program may cover costs to repair or replace facilities damaged during the storm. Interested applicants should contact North Carolina Emergency Management at pahotline@ncdps.gov.
- Read your letter from FEMA carefully. If you applied for assistance, you will receive a letter explaining your

application status. If you are not currently approved for assistance, you may need to send additional documentation to FEMA. You can easily upload documents to Disasterassistance.gov or submit them at a Disaster Recovery Center.

## By the Numbers

- **\$247 million approved to 135,000+ households and individuals** beginning their recovery.
- \$273 million in Public Assistance funding approved to support community recovery.
- FEMA is providing multiple temporary housing options to meet North Carolinians' individual needs. More than 4,950 households are using Transitional Sheltering Assistance hotels and motels. The first step to receiving housing assistance is applying with FEMA.

# **New Hours for North Carolina Disaster Recovery Centers**

- A Disaster Recovery Center (DRC) is a one-stop shop to meet with FEMA representatives, apply for FEMA
  assistance, receive referrals to local assistance, apply with the U.S. Small Business Administration (SBA) for lowinterest disaster loans and more. No appointment is needed.
- Effective Monday, Nov. 25, DRCs will be open 8 a.m. to 6 p.m. weekdays and 9 a.m. to 2 p.m. Saturdays. All DRCs are now closed Sundays. DRCs will be closed Nov. 28–Dec. 1 for Thanksgiving weekend. All DRCs will reopen 8 a.m. Monday, Dec. 2.

## **Direct Temporary Housing Assistance**

FEMA offers several types of housing assistance and temporary shelter solutions for eligible households. Direct Temporary Housing Assistance is approved for 25 counties as an interim solution to permanent housing needs. These temporary housing solutions include travel trailers or manufactured home units, and more will be available soon. These options take time, and individuals will be contacted by FEMA if they are eligible. ## Transitional Sheltering Assistance (TSA) is Still Available

Through TSA, FEMA pays directly to participating hotels and motels to cover the cost of room, taxes and non-refundable pet fees to provide short term accommodations for eligible disaster survivors. If you are eligible for TSA, FEMA will notify you using the contact information you provided on your application.

## **Boil Advisory Lifted in Asheville**

 Customers may resume normal water system usage. Customers with plumbing installed before 1988 are advised to continue flushing cold water for 30 seconds to two minutes before gathering water for consumption.

# **Updated FEMA Programs Better Assist People with Disabilities**

• FEMA funding is available to eligible survivors with disabilities to make certain accessibility improvements to homes damaged by a declared disaster. # **Spending of FEMA Grant Money**

• If you are a disaster survivor in North Carolina who received a federal disaster assistance grant from FEMA, it is important to use the money only for disaster-related expenses. FEMA sends a letter to grant recipients explaining how to use the funds. Disaster grants are not for regular living expenses.

# Online Application is Fastest Way to FEMA Assistance

Homeowners and renters affected by a disaster can apply for federal assistance in several ways: Online at <u>DisasterAssistance.gov</u>, Via the FEMA App (<u>fema.gov/about/news-multimedia/mobile-products</u>), Calling 800-621-3362. If you use a relay service, such as Video Relay Service (VRS), captioned telephone or other service, give FEMA your number for that service.

#### **Appeal a Decision**

You can appeal any FEMA decision or award amount by sending additional documents, like estimates for repairs, receipts, bills, etc., that show you qualify and need more help. Each decision letter from FEMA explains why you are ineligible and the types of documents to help you appeal.
